# Pig Report by Richard Ensz

- Richard updated Rural Revival about local CAFO (Concentrated Animal Feeding Operations) regulations and the impact on small farmers. A recent Turner County situation pitted a CAFO against a local farmer stating that the farmer needed to remove the hogs from his property because they were too close to the CAFO. The small farmer believed he was in accordance with CAFO regulations by being over half of a mile from the facility (CAFO's must be ¼ mile from homes). Currently the small farmer is seeking legal counsel.
